Important Notes : The total number of sections of the school shall be restricted to 14 (as per prescribed dimension) as per the number of class rooms reported during inspection, further increase shall require prior permission of the Board, subject to compliance with the affiliation bye laws.

2. The school has converted regular toilets into CWSN toilets, but they are too small and there is no room for a wheelchair/walker to move around. Further a temporary seat has been put on WC, which is not as per norms. The school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.

3. The school has constructed a ramp at the entrance on a part of the staircase, which looks a temporary structure covered with cloth. This is not as per norms. The school shall construct a permanent ramp with hand rails, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.

4. The composite lab still needs improvement. The school has put chairs therein which are inappropriate. The RC has reported that the sports facilities can be developed more. No separate reading area for staff is seen in

the library. The school shall upgrade the composite lab, library and sports facilities as per SoPs of the Board within 3 months and submit compliance on SARAS.

5. Failure to submit compliance for the above mentioned points within the prescribed time, shall invite financial penalty against the school.

6. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.

7. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time

8. The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.
